

SBIN Bull Call Ratio Spread

Strategy Rationale:

SBIN has seen a sharp correction from 310 levels to 255 levels in last 2 months but on lower side stocks found strong support around 255-260 zone and thereafter has been consolidating between 260-270 range for last few days. In todays session, stock gave a breakout above its resistance zone of 270 and with this added fresh long positions. From current levels, stock is looking bullish and we expect that it can test 290-295 levels in short term. Therefore, we recommend initiating Bull Call Ratio Spread in SBIN at current levels.

Strategy Details

The strategy consists of buying 1 lot of SBIN March 275 Call option at Rs.7.90 and selling 1 lot of March 285 Call and 295 Call at Rs.4 and 2 respectively. The premium outflow in this strategy would be Rs. 5,700.

Profit and Loss Matrix:

Maximum Loss will be Rs.5,700 if stock closes below 275 and maximum profit Rs. 24,300 if stock closes between 285-295 at the time of expiry. However, one needs to hedge the strategy by buying 1 lot of SBIN future if prices breaches 303.

Leveraging Cost

The SPAN margin of complete strategy is 1,22,100 at the time of initiation and may vary depending upon the volatility in the market.

Strategy:

Buy 1 lot of SBIN March 275 Call at 7.90 Sell 1 lot of SBIN March 285 Call at 4.00 Sell 1 lot of SBIN March 295 Call at 2.00
