

Strategy Rationale

The Strategy entails taking benefit of the price movement of both the stocks and takes advantage of the price ratio reverting to the mean. Both the stocks are correlated to each other and 100 days correlation between the two is around 91%. However, in short term Colpal has underperformed Hindunilvr and due to this price ratio has deviated from its mean. This is an ideal scenario where one can buy Colpal and sell Hindunilvr. We expect that from here Colpal will outperform Hindunilvr in short to medium term perspective.
