## Daily Trading Bites I Commodity I





- ➤ In the base metals complex, Copper prices are consolidating in a narrow range since last few trading sessions. On Wednesday, Copper prices recorded the high of 688.40 and low of 674.95 to settle with the gains of more than 1%.
- On the technical front, Copper prices are now trying to form a base near 100 EMA (Exponential Moving Average) on daily chart which is observed at 675 levels. It will act as a key support in the short term.
- ➤ The RSI (14) on daily chart has climbed near 56 mark which signals that counter is gaining strength in momentum on the higher side. The next leg of rally is likely to push Copper prices towards 720 levels in coming sessions.
- We remain bullish on Copper and expect prices to trade higher throughout the day. As a result, we advocate traders to buy on dips in the counter for the targets of 700 to 720 levels.






