

### Market Round Up

On Monday, Nifty August future ended with a gain of 0.84% whereas Nifty Bank August future ended with a gain of 0.44%.

- Nifty August future ended at a premium of 23.85 points compared to its previous day's premium of 14.20 points. Nifty Bank August future ended at a premium of 115.85 points compared to its previous day's premium of 88.80 points. Nifty PCR-OI rose to 1.25 from 1.09.
- Nifty-OI increased by 10.78% and currently stands at 11.41 million shares whereas Bank Nifty OI increased by 0.89%.
- India VIX remained unchanged and closed at 12.80.
- During the day build up of fresh long seen in PVR, GODREJPROP, TATAPOWER, BALKRISIND and BATAINDIA whereas short covering was seen in BRITANNIA, SUNPHARMA, LUPIN and ESCORTS.
- During the day build up of fresh short seen in DABUR and EXIDEIND whereas unwinding of existing long seen in SUNTV.

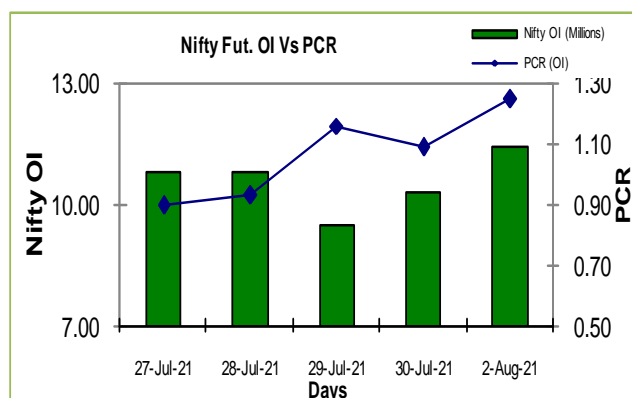
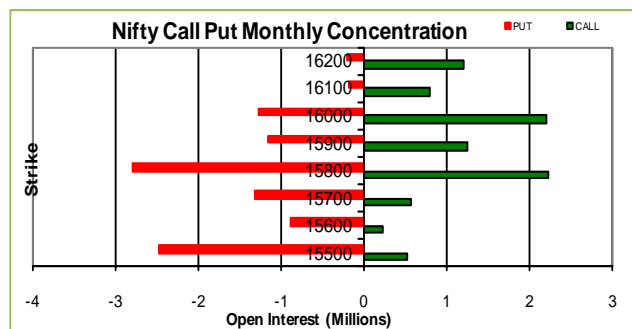

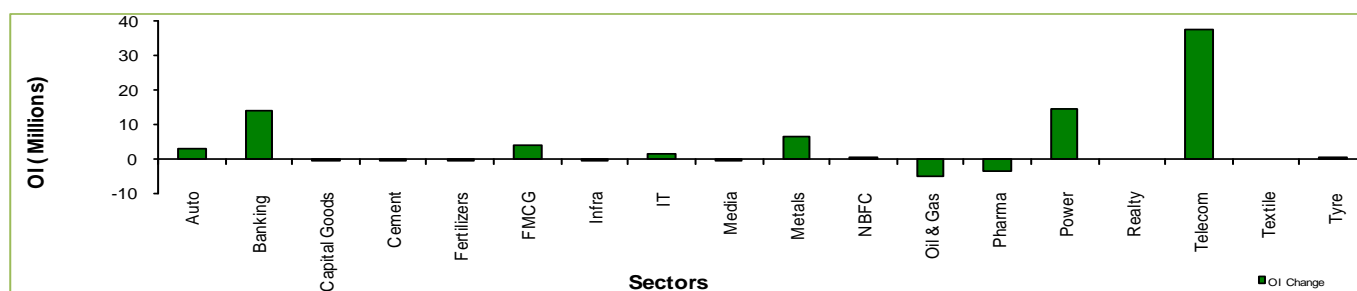
