Market Round Up


On Tuesday, Nifty August future ended with a gain of 1.49% whereas Nifty Bank August future ended with a gain of 1.35%.


- Nifty August future ended at a premium of 15.75 points compared to its previous day's premium of 23.85 points. Nifty Bank August future ended at a premium of 89.25 points compared to its previous day's premium of 115.85 points. Nifty PCR-OI rose to 1.65 from 1.25.
- Nifty-OI increased by 11.83% and currently stands at 12.76 million shares whereas Bank Nifty OI decreased by 15.31%.
- India VIX climbed 7.42% and closed at 13.75 compared to its previous day's close of 12.80.
- During the day build up of fresh long seen in STAR, UBL, CUMMINSIND, DABUR and ASHOKLEY whereas short covering was seen in AXISBANK, HINDUNILVR, HAVELLS and MARUTI.
- During the day build up of fresh short seen in GODREJPROP, VOLTAS and RBLBANK whereas unwinding of existing long seen in CHOLAFIN and PVR.


