## **EURINR AUGUST**



- ➤ After witnessing the correction from the highs of 90.80 to 87.62 levels, EURINR August contract found support at lower levels and bounced back towards 88.86 levels.
- > The above daily chart shows that prices have broken above the downward moving channel after many weeks which provides first confirmation that trend might be reversing on upside.
- ➤ Prices have taken support of the 61.8% retracement of the prior up move and has started to sustain above 20 days of EMA which is in favour of bulls.
- > MACD has been showing positive crossover and now move above 0 level will suggest that further strength might be building up.
- ➤ In short, EURINR August trend is reversing on upside. Close above 89.00 will suggest that move towards 89.80-90.00 level has started. On downside 88.00 and 87.60 will act as support levels.
