

Market Round Up

On Wednesday, Nifty August future ended with a gain of 0.71% whereas Nifty Bank August future ended with a gain of 2.26%.


- Nifty August future ended at a premium of 2 points compared to its previous day's premium of 15.75 points. Nifty Bank August future ended at a premium of 66.30 points compared to its previous day's premium of 115.85 points. Nifty PCR-OI fell to 1.53 from 1.65.
- Nifty-OI increased by 1.80% and currently stands at 12.99 million shares whereas Bank Nifty OI increased by 0.42%.
- India VIX corrected by 3.93% and closed at 13.21 compared to its previous day's close of 13.75.
- During the day build up of fresh long seen in BOSCHLTD, LICHSGFIN and SBIN whereas short covering was seen in KOTAKBANK, HDFCBANK and HAVELLS.
- During the day build up of fresh short seen in COFORGE, RBLBANK, INDUSTOWER, RAMCOCEM, BEL and IBULHSGFIN whereas unwinding of existing long seen in BRITANNIA and TCS.




