

- > Prices have taken strong support at its short term rising trend line currently placed near 48850 level.
- MACD (12,26,9) has also given a positive crossover on the daily chart.
- Therefore, prices are expected to rise further from these levels towards immediate resistance placed around its recent top of 51235.
- > On the lower side, immediate supports are placed around 49800 and 48850 levels. Buying on minor pullbacks is recommended in Silver for the day.




