

Market Round Up

On Wednesday, Nifty July future ended with a loss of 0.65% whereas Nifty Bank July future ended with a negligible gain of 0.03%.

- Nifty July future ended with a discount of 9.45 points compared to its previous day's discount of 33 points. Nifty Bank July Future ended with a premium of 26.10 points compared to its previous day's discount of 24.70. Nifty PCR-OI fell sharply from 1.63 to 1.37.
- Nifty OI reduced by 3.66% and currently stands at 12.62 million shares.
- India VIX gained 3.98% and closed at 26.10 compared to its previous day's close of 25.10.
- During the day build up of long seen in CANBK, TATACHEM, SAIL and NATIONALUM whereas short covering seen in TATASTEEL.
- During the day build up of fresh short seen in UPL and BALKRISIND whereas unwinding of existing long seen in EQUITAS, M&MFIN, ESCORTS and APOLLOHOSP.

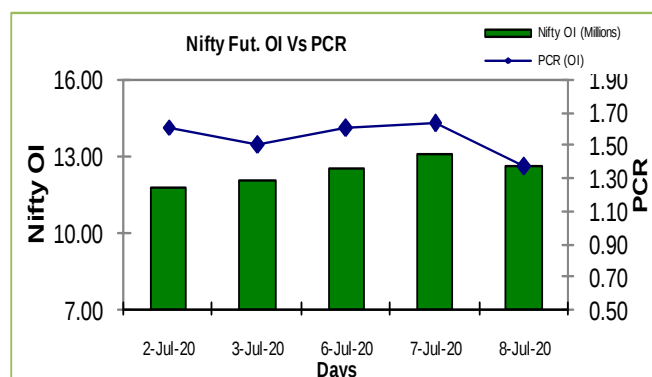
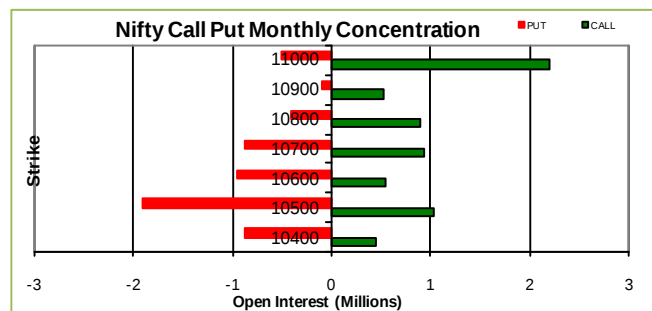

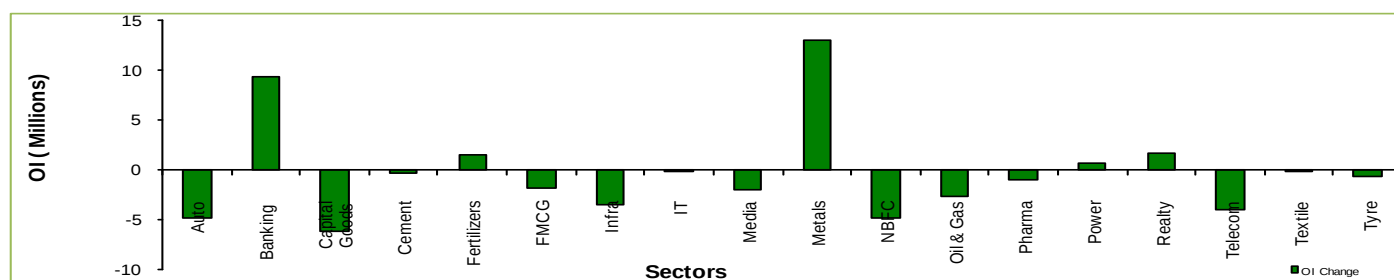
