### **USDINR APRIL**



- ➤ USDINR April had a spectacular last week in which prices broke out above 74.00 levels and gained around 2.34%. This finally confirms that medium term low has been formed at 72.36 level and intermediate up move has started. As per conservative target, prices are going to retest the earlier highs near 77.00 levels.
- > The above daily chart shows that prices have broken out of the prior swing area resistance as well as it has taken out trendline resistance with 100 days EMA. RSI is showing shift in the range. All these together indicates that trend has reversed on upside. Buy on dips strategy should work well now. Crossing above 75.00-75.20 can take it towards 76.40 & 77.00 levels. 73.90 & 73.50 will act as support levels.
- In short, USDINR April trend is positive. Use any dips towards 74.50-74.30 as buying opportunity for a move towards 75.20 and 76.40 levels over next few weeks.
