

Market Round Up

On Wednesday, Nifty Dec future ended with a gain of 0.34% whereas Nifty Bank Dec future ended with a gain of 0.28%

- Nifty Dec future closed at premium of 28 compared to its previous day's premium of 41.40. Nifty Bank Dec Future ended with a premium of 57.50 compared to its previous day's premium of 66.20. The Nifty PCR-OI rose from 1.17 to 1.21.
- The Nifty OI increased by 1.78% and currently stands at 14.30 million.
- India VIX fell by 6.37% and closed at 13.38 compared to its previous day's close of 14.29.
- During the day build of fresh long position seen in DLF and NMDC whereas short covering was seen in UNIONBANK and NIITTECH.
- During the day build of fresh short position seen in YESBANK, UJJIVAN and TATACHEM whereas liquidation of long position seen in EQUITAS and TATAELXSI.



