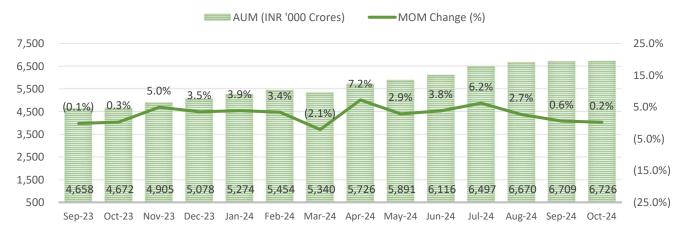

- o Mutual Fund assets rose by 0.6% and stood at 67.26 lakh Cr in Oct 2024 (vs 67.09 lakh Cr in the previous month).
- The industry saw sales amounting to 12.31 lakh crore, up from 11.74 lakh crore previously. Redemptions also adjusted to 9.91 lakh crore, compared to 12.45 lakh crore in the previous month. For October 2024, sales increased by a substantial 4.86%, while redemptions decreased by 20.40%, reflecting notable shifts in market activity.

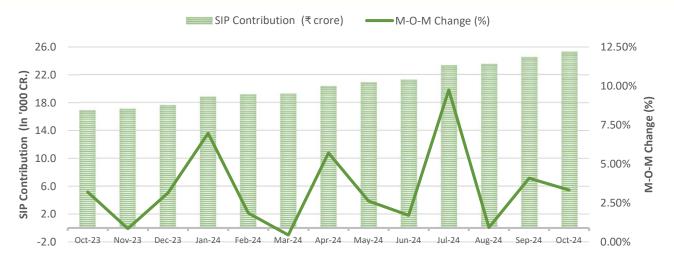
The Industry witnessed an inflow of 2.39 lakh Cr in October 2024 as compared to an outflow of 71.1 thousand Cr in the previous month due to major inflows in debt specifically in Liquid Fund.

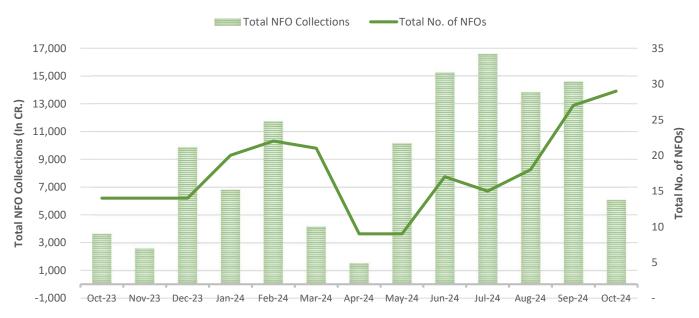
SIP FLOWS

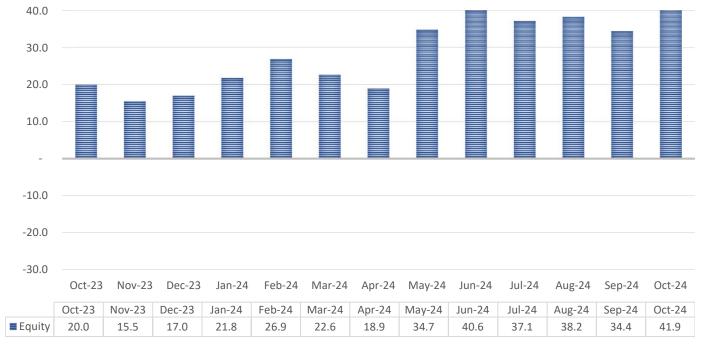
The NFO collections for the month decreased to 6,078 Cr as compared to 14,575 Cr in the previous month even though total 29 new schemes were launched.

Net Equity Inflow / Outflow ('000 Crores)



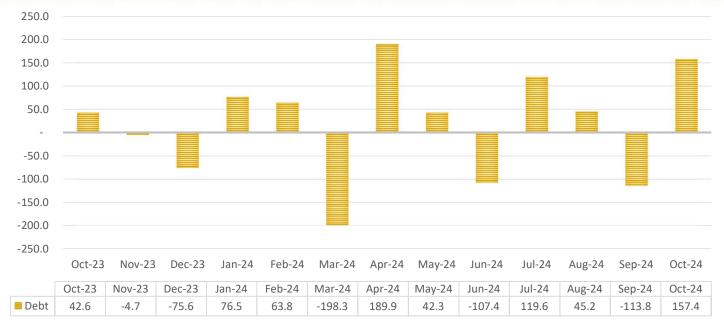
- o The equity open-ended category experienced a increase in net inflows of 41,887 crores compared to 34,419 crores. All equity open-ended categories witnessed an inflow of funds.
- Among equity categories, the Sectoral/Thematic category continued to garner the highest inflows amounting to 12,279 Cr, majorly contributed by Sectoral category NFO's which collected 3,517 Cr. Flexi Cap and Large & Mid Cap Fund category also witnessed high inflows of 5,181 crore and 4,857 crores, respectively.
- o Overall category saw a growth of 5.13% compared to 2.10% for the previous month.





Debt AUM Comparison and Analysis

Net Debt Inflow / Outflow ('000 Crores)



- The debt open-ended category saw an inflow of 1,57,402 crores, contrasting with an outflow of 1,13,834 crore the previous month. Notably, the liquid category experienced a major inflow of 83,863 crores.
- In the Debt category, the major inflows were also observed in the Overnight Fund,
 Money Market Fund amounting to Rs 25,784 crore, and Rs 25303 crore respectively.
- o The overall debt category appreciated by 8.10% compared to -9.23% in the previous month.
- Meanwhile, the Medium Duration Fund and Credit Risk Fund have seen outflows of 149 crore, and 358 crore, respectively.





Hybrid AUM Comparison and Analysis

Net Hybrid Inflow / Outflow ('000 Crores)



- o In October 2024, inflows into the hybrid category totaled 4,901 crores, compared to 10,005 crores in the previous month.
- o The Multi Asset Allocation category witnessed the highest inflow of 3,797 Cr, followed by the Dynamic Asset Allocation/Balanced Advantage category amounting to 2,456 Cr.
- o Overall, the hybrid category witnessed a capital appreciation of 1.40% for the month.
