Technical Outlook

Trading for the week started on cheerful note and Nifty index made its opening tick above 10300 marks. Post opening, index witnessed mild profit booking however Nifty manage to recouped its gains during the second half. In the process, index added another 0.55% into bull's kitty. On a daily chart, Nifty precisely closed at 78.6% retracement of its recent swing move. Now, index is approaching towards its upper band of its channel formation also the gap area of 10333 / 10346 likely to act as an immediate hurdle. On the flip side, yesterday's gap area of 10282 / 10271 will act as an immediate support.

Technical Outlook

The Nifty Bank index opened higher with a gap of nearly 114 points in line with the benchmark indices. Post opening, we haven't seen any significant movement as index traded in a narrow range and eventually concluded the session with a gain of 0.33%. During the day, we saw decent traction across the PSB which outperformed the index. Going forward, index has an immediate resistance near 25520 which coincides with the 61.8% retracement above which index likely to rally towards 25700. Lower side, 25265 / 25100 are near term support.
