
## Daily Trading Bites I Commodity I

- Crude oil prices opened slightly higher in the last session and prices rose further for first half of the session till high of 3815. Later prices corrected for the remaining session and closed flat.
- > Prices have broken out from its short term declining trend line resistance and also closed above the same in the last session.
- ➤ Prices are expected to recover further from these levels towards immediate resistance placed around its recent multiple swing highs near 3865 level and further towards 23.6% Fibonacci retracement of its fall from high of 5669 till low of 3464, which is placed at 3984 level.
- ➤ On the lower side immediate supports are placed around 3720 and 3655 levels.




