Market View from the Technical Research Desk

Nifty (25898.55)



The index snapped its losing streak and closed positive in yesterday's session. It opened with a gap of +13.4 points and ended 140.55 points higher. HDFC Bank Ltd, Kotak Mahindra Bank Ltd, and Eternals Ltd were the biggest contributors to yesterday's gains. On the technical front, the index continues to trade below the shortterm 10- and 20-DEMA lines. The bearish head-and-shoulders pattern remains intact on the daily chart, and the index faced strong resistance near the neckline in yesterday's session. It is also trading within a bearish lower-low and lower-high pattern. However, at lower levels, the index has found good support at the 50-DSMA; as long as it trades above this level, the positional trend remains bullish. Any sustained weakness below the 50-DSMA will put additional pressure on the market. Immediate support is placed at 25,750-25,650, while resistance is seen at 25,950-26,000. Sustained strength above 26,000 can attract more buying. The possible trading range for tomorrow can be 25,950-25,750/25,650.

Bank Nifty (59209.85)



The index was positive in yesterday's session. It opened with a gap of +5.8 points and rallied another 457.15 points. However, it couldn't sustain at higher levels and pared some gains, closing 249.45 points lower. On the technical front, the index found good support near the low of the bullish marubozu candlestick formed on 26th November. It witnessed a strong bounce and closed near the short-term 20-DEMA line in yesterday's session. Though the daily trend continues to be bullish, the index is showing initial signs of weakness. It has formed a bearish head-and-shoulders pattern on the daily chart. In yesterday's session, the index moved above the neckline but couldn't sustain and closed back below it. For the last four trading sessions, the index has been unable to close above the prior day's high. The RSI is consistently trending lower. The index also closed below the 20-DEMA line in the 10th December session. All these factors indicate early signs of weakness and should not be Immediate support is placed at 58,800-58,650, while resistance will be seen at 59,200-59,400 levels. Any sustained strength above 59,400 will invite more buying, whereas sustained weakness below 58,650 will invite more selling. The possible trading range for tomorrow can be 58,800/58,650-59,200/59,400.
