USDINR JANUARY



- ➤ USDINR January has continued to trade with negative bias over last few days. Prices found resistance near 73.70 levels and reversed on downside towards 73.10 levels. Prices are now back near to the previous swing area of 73.00-72.90 levels. The continuous flow by FII in Equity Markets has been keeping trend of USDINR in appreciating mode. Now it will be important to see whether it manages to hold near the swing area support or not.
- ➤ The daily chart shows that prices have taken resistance of 20 days EMA and now channel support is placed at 73.00-72.90 levels. Thus one need to keep close attention near these levels. Any close below the same can result into further downside. On the flip side, any move back above 73.70 will suggest that trend has reversed on upside.
- ➤ In short, USDINR January is trading at crucial juncture. One needs to be alert near 73.00-72.90 levels. On upside 73.70 is the crucial resistance.
