
Market Round Up

On Friday, Nifty May future ended with a gain of 0.03% whereas Nifty Bank May future ended with a loss of 0.78%.


- Nifty May future ended with a premium of 37.15 points compared to its previous day's premium of 13.55 points. Nifty Bank May future ended with a premium of 95.65 points compared to its previous day's premium of 68 points. Nifty PCR-OI fell to 1.29 from 1.11.
- Nifty-OI decreased by 5.52% and currently stands at 12.33 million shares whereas Bank Nifty OI increased by 10.26%.
- India VIX gained 0.95% and closed at 20.27 compared to its previous day's close of 20.08.
- During the day build up of fresh long seen in PIDILITIND, ASIANPAINT, BERGEPAINT and UPL whereas short covering was seen in VOLTAS, CHOLAFIN, BRITANNIA and BIOCON.


