Technical Outlook

Yesterday, the Nifty index opened higher with a gap of nearly 36 points and we saw decent traction during the first half. In that optimism, index surpassed 10600 marks however it encountered tremendous sell-off which had a rub-off effect as index pared some of its early morning gains. Looking at the daily chart, once again the daily 45-EMA acted as a strong hurdle for Nifty as index turned sharply after testing the said indicator. The Bollinger band on hourly chart has contracted indicates volatility likely to increase in the near term. For the day, 10600 / 10653 are immediate resistance whereas 10490 / 10440 are intraday support.

Technical Outlook

Yesterday, the Nifty Bank index opened marginally higher and buying interest in the index heavy weight ICICI Bank drive index higher. However, such move proven to be short-lived as index gradually descended lower and trimmed early morning gains. In the process, Nifty Bank index ended the session with a nominal gain of 0.33%. At this juncture, index consolidated in narrow range hence traders are advice to concentrate on stock specific trades. For the day, 25265 / 25100 are intraday support whereas 25585 / 25745 are immediate resistance.
