Subsequently, stock witnessed decent profit booking as a result stock corrected till 1830.</li> </ul>	
Symbol: RELIANCE Entry Point: 2102	<ul> <li>Since, the beginning of November 2020, stock has been consolidating in broad range of 1830 – 2120 levels and during this consolidation stock formed a "Descending triangle pattern". Yesterday, stock confirmed its breakout from said triangle by penetrating its "Downward Sloping Trend line". During the course of its consolidation, stock price slipped below its 200 DMA but it barely sustained for three sessions and rebounded sharply.</li> </ul>	
Target: 2640	<ul> <li>Technically speaking, Reliance stock price has came out from its consolidating phase and resumed its primary trend which we believe to be a bullish. The recent all-time high of 2369 will be an immediate hurdle whereas the overall target of said triangle pattern comes near 2640.</li> </ul>	
Stop loss: 1800	<ul> <li>The momentum indicator RSI (14) has crossed the previous swing high of 56 mark on we scale whereas stochastic oscillator marking positive crossover which support our hypothesis.</li> </ul>	
Risk Reward: 1: 1.78 ✓ Hence, going through the above analysis, we believe that Reliance Industries re rally. Therefore, we advise medium term traders as well as investors to buy current level of 2102 with an upside targets of 2640 levels. Stop loss to be recent consolidation phase at 1800 mark.
