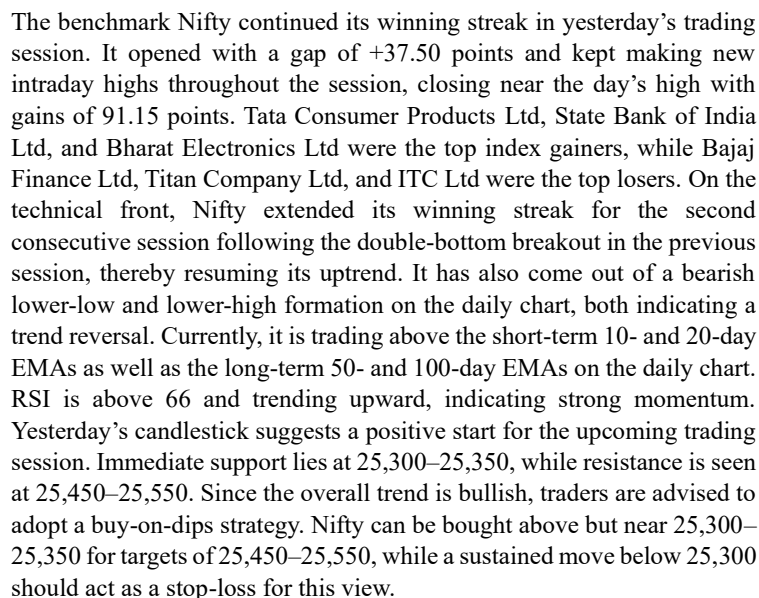


Daily EQ Trend

Bank Nifty continued its winning streak for the eleventh straight session. It opened flat with a mere +10-point gap-up and kept making new intraday highs throughout the session to close with gains of 345.7 points. Punjab National Bank Ltd, State Bank of India Ltd, and Canara Bank Ltd were the top index gainers, while IndusInd Bank Ltd, AU Small Finance Bank Ltd, and ICICI Bank Ltd were the top losers. On the technical front, Bank Nifty has given a falling resistance trendline breakout on the daily chart, indicating a trend reversal. In yesterday's session, it also broke above the 50-day EMA resistance and now trades above the short-term 10- and 20-day EMAs as well as the long-term 50- and 200-day EMAs on the daily chart. RSI is above 59, indicating strong momentum. On the intraday 15-minute chart, Bank Nifty has been consistently forming higher highs and higher lows. The immediate trend remains bullish with strong momentum. Yesterday, it formed a healthy bullish green candlestick on the daily chart, suggesting a positive opening for the upcoming session. Immediate support is placed at 55,400–55,200, while resistance is seen at 55,550–55,750–55,950. Since the overall trend is bullish, traders are advised to adopt a buy-on-dips strategy. Bank Nifty can be bought near 55,400 for targets of 55,550–55,750–55,950, with a stop-loss placed below 55,200.
