- USDINR pair was consolidating near key levels since last few trading sessions. USDINR pair recorded the high of 82.66 and low of 82.47 to settle on a flat note on Friday.
- On the technical front, USDINR pair is now hovering near the 20day moving average which is observed near 82.60 levels. A decisive breakout above this level is likely to push prices towards 84.00 levels in the medium term.
- > The RSI (14) on daily chart has climbed near 60 mark which signals that the counter is gaining strength in momentum.
- Key support is now observed near 81.50 levels. Breaking below this level, USDINR pair is likely to test the psychological support of 80.00 levels.
- We turn bullish on USDINR pair and expect prices to trade higher throughout the day. As a result, we advocate traders to buy on dips in the counter as long as immediate support is not broken on closing basis.
