Technical Outlook

The nifty index opened marginally higher and struggling to cross 11000 marks during the initial hour of trade. Subsequently, the bouts of selling pressure pulled index lower as a result nifty corrected towards its immediate support of 10925 and eventually ended inside the negative territory. Looking at the hourly chart, nifty is trading in a range of 11080 – 10925 and formed a channel pattern and currently nifty is hovering near the lower band of channel. Going forward, 10925 will act as a strong support and a decisive break below this level will pull nifty lower towards 10876. Higher side, 10995 – 11030 are intraday hurdles.

Technical Outlook

The Nifty Bank index opened higher with a mild gap and went tad above 27000 marks during the initial hour of trade. Subsequently, we saw decent profit booking in private banking space which dragged index lower. In the process, nifty bank index eventually ended the session with a loss of 0.34%. Looking at the daily chart, the recent swing low of 26644 will act as an immediate support and any break below this level will trigger fresh sell-off in that case index likely to slide towards 26500. Higher side, 26940 – 27085 are near term hurdles.
