
Market Round Up


On Monday, Nifty March future ended with a loss of 0.832 and whereas Nifty Bank March future ended with a loss of 0.57%.

- Nifty March futures ended with a premium of 39 points compared to its previous day's premium of 189 points. Nifty Bank March futures ended with premium of 153 points compared to its previous day's premium of 236 points.
- Nifty Future-OI moved down by 2.44% and currently stands at 19.78 million shares whereas Nifty Bank Future-OI increased by 2.99%.
- India VIX increased by 8.39% and closed at 16.01 compared to its previous day's close of 14.77. Nifty PCR-OI has increased to 0.96 from 1.05
- During the day buildup of fresh long is seen BPCL and GODREJCP, whereas short covering is seen in MRF and IOC. During the day buildup of fresh short is seen GAIL and INDIACEM, whereas unwinding of existing long is seen in ONGC and TRENT.




