On Tuesday, Nifty September future ended with a loss of 0.84% whereas Nifty Bank September future ended with a loss of 0.97%.


- Nifty Sep Future ended with a premium of 8.40 points and Oct Future ended with a premium of 27.50 points. Nifty Bank Sept Future ended with a premium of 44.55 points and Oct Future ended with a premium of 47.45 points. Nifty PCR-OI fell to 1.04 from 1.07.
- Nifty OI further reduced by 1.55% and currently stands at 10.81 million shares.
- India VIX corrected by 3.50% and closed at 21.41 compared to its previous day's close of 22.19.
- During the day build up of fresh long seen in ADANIENT whereas short covering was seen in SAIL.
- During the day build up of fresh short seen in JINDALSTEL, ONGC, APOLLOHOSP, RBLBANK and CANBK unwinding of existing long seen in MFSL, GLENMARK, IDFCFIRSTB and ESCORTS.




