## Market Round Up

Last week, indices opened on positive note and thereafter continued to trade in narrow band of 10520-10600 levels. On higher side, nifty failed to breach 1060 levels and constant profit booking was seen that kept indices under pressure. In Fridays session, for most part of the day nifty traded in negative zone but recovered in last hour of trades and closed around 10565 levels down by 1 points.

- Nifty and Nifty IT fut. saw long accumulation in Fridays session whereas short positions were added in banknifty futures.
- Fresh short positions were added in banking, power, oil marketing and nbfc sector. Canbank, idbi, dhfl, orientbank, bergepaint and rpower were some of the stocks that saw short accumulation.
- Long positions were initiated in technology sector and stocks like ofss, mindtree, srf, bata, wockpharma, tataelxsi and infy.
- Long unwinding pressure was seen in metal sector and stocks like dcbbank, cholafin, arvind, repcohome, mrf and vedl.

Markets are expected to open on flat to negative note in today's session but on lower side will continue to se buying interest around 10520-10500 levels. Overall, markets are stuck in narrow band of 10500-10600 zone and breakout from this range on either side will further set the direction for indices in short to medium term perspective. Breach below 10500 can drag nifty towards 10420-10380 levels whereas above 10600 it can test 10680.


