Market Round Up

On back of one sided election mandate, Indian bourses opened with positive gap and thereafter nifty breach 12000 levels for first time and made all time high of 12031 levels. However, from those levels sharp profit booking pressure was seen across the board that dragged nifty below 11700 levels and finally nifty closed around 11657 with loss of almost 80 points.

- From higher levels, long unwinding coupled with fresh short accumulation was seen in all the major indices. Nifty fut. added almost 2.80 lakh shares in OI and closed at 35 points premium.
- Profit booking in long positions was seen in power, pharma, capital goods and auto sector. Major unwinding was seen in stocks like rpower, cgpower, bergepaint, tatamtrdvr, kscl and jet airways.
- Fresh long positions were added in bankbaroda, adaniport, engineersin, divislab, indiacem and dishtv.
- Short accumulation was seen in metal, fmcg and technology sector.
 Hdfcbank, itc, apollohosp, srf, nationalum and hindzinc were some of the stocks that saw short addition.
- Cipla, relcapital, bhel, mgl, bharatfin and shreecem were some of the stocks that saw short covering in yesterday's trade.

After yesterday's high volatile session, today markets are expected to open on positive note and will continue to see buying support at lower levels. On lower side 11600-11500 will act as strong support for nifty in short to medium term perspective whereas a move towards 11900-12000 levels can be used to book profit in trading positions.






