- USDINR October prices reversed from the lows of 73.35 level in the start of September 2021 towards 74.20 levels and post that it has continued to trade in non trending environment.
- The above daily chart shows that prices are intact in contracting structure wherein it took support of the upward rising trendline and bounced back. As per this pattern, there is high likelihood that we are going to witness upside breakout in coming days.
- From Intermarket perspective, US Dollar index is on verge of breaking above 94.00 levels which can strengthen USDINR and on the other side Crude prices have continued climb higher which is supportive for USDINR.
- As long as 73.50 is intact on downside, expect upside trend to resume in this pair.
- In short, USDINR October is in range and upside breakout is possible above 74.20 level which will open target towards 74.60 and 75.00 levels.
