#### **Technical Outlook**

Trading for the week kick started with marginally lower opening owing to uncertainty across the globe. Post opening, Nifty broke its previous day's low which triggered massive sell-off. The mighty bears put tremendous pressure on index as a result Nifty slipped below 17000 psychological mark. This was followed by mild recovery during the fag end of the session which resulted into a close with a loss of 2.66%. Despite correcting for last four trading sessions, the bears not in mood to show any mercy and Nifty nosedived below 17000. Looking at daily chart, Nifty slipped below its 61.8% retracement support of its entire rally from 16410.20 to 18350.95. Going forward, Yesterday's low will be a crucial support and if Nifty breaches 16997.85 in that case index might correct till 16850. Higher side, 17450 – 17600 are near term resistances.



### **Technical Outlook**

Yesterday, Nifty Bank opened tad higher which was merely a formality as index witnessed sustain selling pressure right from the beginning of the session. Subsequently, the selling pressure accelerated as index broke its previous day's low of 37741 and extended its fall till 36375.35. This was followed by mild recovery during fag end of the day. In the process, Nifty Bank ended the session with a loss of 1.67%. Looking at daily chart, yesterday's low of 36375.35 coincided with 50% Fibonacci retracement support of its entire rally from the bottom of 34018.45 to the top of 38855.55. Due to yesterday's fall, index broke its 20-DMA and closed below the same. Now, yesterday's low of 36375.35 will be an immediate support below which 200-DMA support peg near 36000. Higher side, 37350 – 37600 are near term resistances.
