Market Round Up

Indices opened on flat note in yesterday's session and thereafter for most part of the day traded in narrow band of 15-20 points. However, in second half sharp short covering pullback was seen across the board that helped nifty to close at day's high level of 11726 with gain of almost 150 points.

- Long accumulation was seen in nifty and banknifty whereas NiftyIT saw short covering form lower levels. Nifty added almost 21.98 lakh shares in OI and May fut. closed at 100 points premium.
- Short covering pullback was seen in fmcg, nbfc, technology, power and metal sector. Major unwinding was seen in stocks like orientbank, justdial, infibeam, indianb, kscl and irb.
- Fresh long positions were initiated in oil&gas and banking sector.
 Ongc, pageind, ultracemco, hindpetro, lt and relcapital were some of the stocks that saw buying interest.
- Selected short positions were added in tataelxsi, acc, mrf, powergrid, apollohosp and mgl.
- Hexaware, tataglobal, apollotyre, torntpower, bsoft and tatachem were some of the stocks that saw profit booing in long positions.

After yesterday's stupendous rally, today markets are expected to open on flat note but will continue to see buying support at lower levels. However, on higher side nifty will find strong resistance around 11800 levels and from those levels profit booking can be seen. Being the last day of expiry, high volatility will be there in second half of trades thereafter traders are advised to keep strict stop losses in their positions.






