

Market Round Up

On Monday, Nifty Jan future ended with a loss of 1.19% whereas Nifty Bank Jan future ended with a loss of 1.44%.

- Nifty Jan future closed at a premium of 6.70 compared to its previous day's premium of 23.35 whereas Feb series closed at a premium of 47.30. Nifty Bank Jan Future ended with a premium of 41.65 compared to its previous day's premium of 88.60. The Nifty PCR-OI fell from 1.42 to 1.11.
- The Nifty OI rose by 3.02% and currently stands at 15.33 millions.
- India VIX climbed by 10.41% and closed at 17.18 compared to its previous day's close of 15.56.
- During the day build up of fresh long position seen in CHOLAFIN and JUBLFOOD.
- During the day build up of fresh short position seen in TORNTPHARM and RAMCOCEM whereas unwinding of long position seen in BALKRISIND and WIPRO.

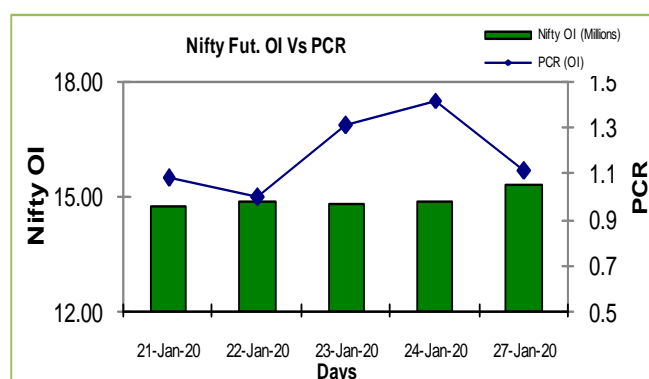
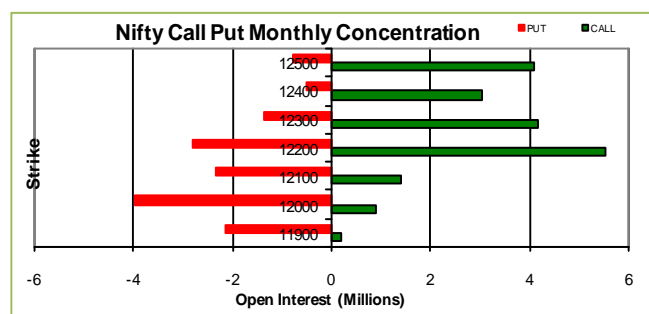

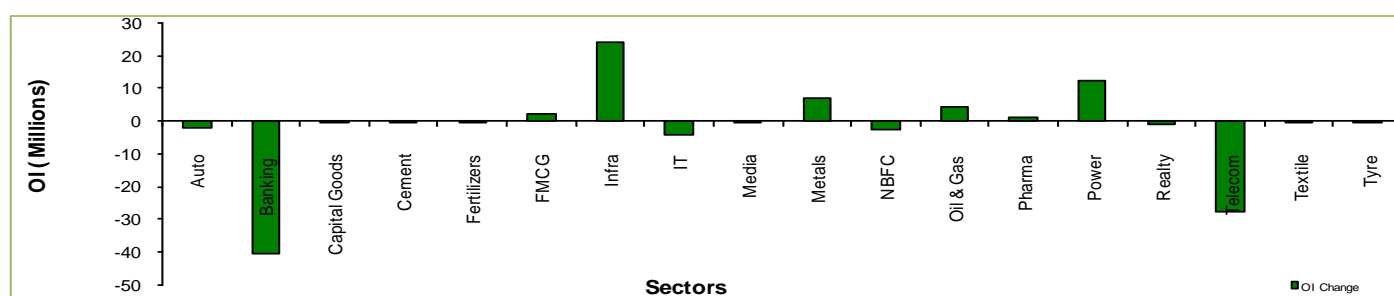
