#### **Technical Outlook**

Following the Thursday, recovery, Nifty index extended its gains even on the Friday's session after opening at 12174 and it surged till the high of 12272 and finally settled at 12248 gaining 0.56%. Index has recovered more that 50% of the sharp fall seen from 12431 – 12087 mark now the next resistance of 61.8% is placed at 12300. Although the daily candle stick pattern looks positive, the weekly candle stick is referring bearish signs. Therefore, we expect Nifty index could witness selling pressure at higher levels. While, supports on immediate basis are placed at 12170 then 12100 levels. The momentum indicators RSI(14) has surged till 53 and stochastic making positive cross over at the lower levels are signifying further bullish strength on technical front.

#### **Technical Outlook**

Nifty bank index started the session with minor gains at 31040 and gradually inched higher till 31375 and finally settled at 31241 gaining 0.77%. Nifty bank index which gave bearish break down of Head and shoulder pattern in the prior session has reclaimed above the neckline of the pattern. Therefore, the neckline support of 31000 will once again act as crucial support. As long as index holds above the neckline, recovery in the index is likely be seen till 31700 then 32000 levels in coming sessions. The trend supportive indicators RSI (14) which slipped into oversold zone is recovering from the lows and stochastic has made positive cross over during Fridays session.
