## **Daily Trading Bites** I Commodity I



- After recording the high of 749 on 8th June, Natural Gas prices  $\geq$ have been consistently trading lower since last two weeks. We have witnessed a lower high and lower lows formation on daily chart since last few trading sessions. On Friday, Natural Gas prices settled with a loss of 1.50% near 488 levels.
- On the technical front, the RSI (14) on daily chart has fallen near  $\triangleright$ 31 mark which signals bearishness in the counter. Natural Gas prices have recently broken below the 100 EMA level on daily chart which is now observed near 525 levels. It has triggered fresh downtrend in prices and will act as crucial hurdle in the short term. Natural Gas prices are poised for a further free fall which could drag prices even below 450 levels in the medium term. On weekly chart, prices have broken below 20 weeks moving average which could also be a trigger for a fresh leg of move on the downside.
- $\geq$ We remain bearish on Natural Gas and expect prices to trade lower throughout the day. As a result, we recommend traders to sell on rise in the counter for the potential targets of 475 to 465 levels.
