- ➤ USDINR pair has been trying to break on the higher side since last several trading sessions. On Friday, USDINR pair traded in a narrow range and settled on a flat note near 78.35 mark.
- > On the technical front, USDINR pair has been taking support at upward sloping 20-day moving average which is now observed near 77.90 levels. The RSI (14) on daily chart has been hovering around 70 mark which signals bullishness in the counter. The weekly chart signals that USDINR pair is poised for a parabolic move on the higher side which could push prices beyond 80.00 mark in the medium term. Breaking above 80.00 level, we may witness sharp uptick in prices towards 82.00 mark.
- ➤ We remain bullish on USDINR pair and expect prices to trade higher throughout the day. As a result, we recommend traders to buy USDINR pair on dips for the potential targets of 79.00 to 79.30 levels.
