# **Special Technical Report: Hindustan Zinc Ltd**



Technically, the stock is witnessing a build-up of bullish momentum on the daily chart. The counter has recently given a breakout above its 200-day EMA resistance and is now sustaining comfortably above the short-term 10- and 20-day EMAs as well as the long-term 50-, 100- and 200-day EMAs. The RSI is trending above 60, reaffirming strong positive momentum. A higher-high, higher-low formation is visible on the daily timeframe, validating the ongoing bullish structure. The stock has also derived strong support from the rising trendline in conjunction with the momentum-driven moving averages. Overall, most technical indicators are pointing toward sustained bullish momentum and a reversal of the prior downtrend. Immediate support is placed at 461 and 454, while the stock holds potential upside towards 540 and 550. Given the favorable risk–reward setup, traders are advised to accumulate the stock on declines toward 470 for an eventual move toward 540-550, while a decisive break down below 440 shall serve as a stop-loss for the prevailing view.
