
Daily Trading Bites I Commodity I





- In the energy complex, Natural Gas prices have recovered sharply in last tow weeks from the multi week lows of 403 levels. Natural Gas prices are now hovering near 600 mark since last few days. Prices settled with the gains of nearly half a percent on Tuesday.
- On the technical front, Natural Gas prices are trying to form a base near 100 EMA (Exponential Moving Average) on daily chart which is observed at 550 levels. It will act as a key support in the medium term.
- ➤ The RSI (14) on daily chart has climbed near 60 mark which signals strength in momentum on the higher side. A decisive breakout above the recent high of 616.90 could push Natural Gas prices towards 670 to 680 levels in the coming sessions.
- ➤ We remain bullish on Natural Gas and expect prices to trade higher throughout the day. As a result, we advocate traders to buy on dips in the counter for the targets of 620 to 630 levels.




