


- > Natural gas prices opened strongly higher with gap in the last session and prices consolidated for most of the session in the range of 130-132 levels.
- > Prices have been recovering gradually after taking strong support near 124 level while, MACD (12,26,9) has also given a positive crossover on the daily chart.
- > Therefore, prices are expected to recover further from these levels towards immediate resistance placed around 23.6% Fibonacci retracement of its fall from high of 205.90 till low of 117, which is placed at 138 level.
- ➤ On the lower side, immediate supports are placed around 129.50 and 124 levels. Buying on minor pullbacks is recommended in Natural gas for the day.
